



16) The Story So Far

We've looked at how the Indies stamped their mark on Fenland, so now we'll turn our attention to the TV boys. Dale Martin had their own stranglehold on Kings Lynn and Peterborough, but they weren't the only Joint organisation going up against the independents. Wryton Promotions captured Spalding before Bill Clark's Starr Promotions got going in that area. So what follows is a simple selection of flyers, posters, clips and comments to give a flavour of the 'names' that entertained the fans between TV shows in the Fens through the late sixties. First, let's look at Spalding's Savoy venue (R).

Wryton booked Jackie Pallo (above) and Les Kellett as regulars for Spalding, which gave them a bit of a problem making sure other bill-toppers really were going to keep the punters coming. They managed it very well.

As you can see from the following adverts Wryton pulled out all the stops, making sure Spalding got the cream of foreign fighters – like Shozo Kobayashi and Chief Billy White Wolf – as well as the home-based boys.

The first programme is from September 1967, and top of the bill is Jackie Pallo v Johnny Kwango, with the pre-USA Pat Barrett against Johnny Yearsley as support. Not bad, eh? It came to pass that Pallo and Kwango ... and isn't it great they can be billed without Christian names ... was actually an annual event for Kings Lynn.

Here we've got 1967, 1968 and 1969 ... and I guess it went on longer than that






Three Kwango v Pallo's! The September bill is from 1967, the May poster is 1968, and the December 13 Pallo v Kwango was the final spectacular of the sixties for Kings Lynn fans.



Here's another double meeting – with a difference. Joint started advertising Taras Bulba from Peru with quite a fanfare, and a frequent opponent was Tibor Szakacs. Kings Lynn was no exception and they topped the bill in 1967 (L). Fifteen months later we're back at Kings Lynn and the internationally confused French/Dutch/Peruvian is back as Le Grand Vladimir (below) ... and who is in the opposite corner? You guessed it. The great Tibor Szakacs. A fine moment captured with this poster and advert ...



Some other highlights of 1967 from Kings Lynn were appearances from Americans who really did face the best across the Atlantic, including Jim Osborne and the disappointingly out-of-condition Crusher Verdu as well as Buddy Montes. And their opponents were no pushovers. They were Johnny Yearsley, Docker Don Stedman, and the original Outlaw.
